

**SUBMISSION OF ANNUAL REPORTS OF GOVERNMENT ENTITIES TO CABINET
AS AT 20 FEBRUARY 2023**

The status report provides information on the submission of Annual Reports of Government entities, through their respective portfolio Ministries, to the Cabinet as at 20 February 2023. The focus is on Government entities that are legally required to submit Annual Reports to the portfolio Minister for subsequent tabling in the Houses of Parliament.
