

**SUBMISSION OF ANNUAL REPORTS OF GOVERNMENT ENTITIES TO CABINET
AS AT 6 NOVEMBER 2023**

The status report provides information on the submission of Annual Reports of Government entities, through their respective portfolio Ministries, to the Cabinet as at 6 November 2023.
