

Report on Appointments to Boards of Public Bodies and Other Entities Approved/Amended by Cabinet during the period 29 September 2025 to 23 February 2026

This Report covers appointments to 140 bodies approved and/or amended by Cabinet during the period 29 September 2025 to 23 February 2026. These bodies fall within the following broad categories: advisory board; authority; board of management; board of statutory body/body corporate; commission; committee; council; executive agency; planning authority; task force; and tribunal.

Not all of these entities are public bodies. According to the Public Bodies Management and Accountability Act, 2001, a public body is a statutory body or authority or any government company, but does not include an executive agency designated under the Executive Agencies Act. The Act defines a statutory body or authority as a body corporate established by an Act of Parliament over which the Government or an Agency of the Government exercises control. The Act also defines a government company, also termed as a limited liability company, as one that is registered under the Companies Act, being a company in which the Government or an agency of the Government, is in a position to direct the policy of that company.

Regulation 20 of the Public Bodies Management and Accountability (Nomination, Selection and Appointment to Boards) Regulations, 2021 provides for a transition period during which boards of public bodies should submit the resignation of their members to the relevant appointing authority, which shall not take effect until a new board is appointed. The transition period is that from which the Governor General issues orders that an election be held to the date of appointment of a new board or the period from the date on which a Minister is appointed until the date he/she appoints a new board or requests in writing that the existing board continues. Regulation 21 of the afore-mentioned Regulations also outline the circumstances for changes in the membership of the board of a public body. These include a change of government or where there is a change in the responsible Minister and the Minister makes a decision to appoint a new board.
